Dear President Biden,

As you wrap up your term in office, the threat of escalation in the Middle East looms large. Israel continues its wars in Gaza and Lebanon, and the cycle of retaliation with Iran continues. The administration's policy towards Israel has failed, and in the time you have remaining as president it is essential that you begin charting a new course. In particular, we urge you to hold Israel accountable to U.S. law, ending arms sales to Israel to protect U.S. interests, achieve a ceasefire, protect civilians, increase aid access in Gaza, secure the release of the hostages, and work towards a stable future for the region.

The current policy of unconditional support of Israel paired with empty threats has brought the U.S. to the brink of war and allowed a close partner to commit apparent war crimes<sup>1</sup> using U.S. military aid and taxpayer dollars.<sup>2</sup> Israel has bombed hospitals, schools, and residential areas<sup>3</sup>, blocked humanitarian aid, and killed tens of thousands of civilians, including journalists<sup>4</sup> and humanitarian workers,<sup>5</sup> without the United States' "full support"<sup>6</sup> ever wavering.

Not only has Israel misused U.S. aid, they have actively put U.S. troops and interests in danger. In multiple instances, Israel has taken major escalatory actions, reportedly without giving the U.S.

government advance notice,<sup>7</sup> despite knowing that the retaliation would likely impact U.S. bases and service members in the region, as well as American citizens in Gaza, the West Bank, and Lebanon.

Without strong U.S. presidential leadership willing to use the office's significant leverage to rein in their tactics, the Israeli government has no incentive to change its behavior. Continuing with the status-quo approach risks additional escalation, further devastation for civilians — including hostages — in Palestine and Lebanon, and the United States being dragged into another war in the Middle East.

Much of Israel's conduct has been in violation of international law and the continued provision of military assistance to Israel is in direct violation of U.S. law. Up to this point, the administration has been unwilling to enforce the law, but there are opportunities to hold Israel accountable moving forward. While a 30 day deadline to comply with longstanding U.S. laws is not required, the letter from Secretaries Blinken and Austin sent to Yoav Gallant in October, demanding Israel permit the delivery of U.S. humanitarian assistance, provides an opportunity to course correct U.S. policy and finally enforce section 620I of the Foreign Assistance Act. As you know, this law requires the U.S. government to withhold all military assistance until Israel permits U.S. humanitarian aid access. To safeguard our own democracy, we encourage you to ensure that U.S. law is enforced, in this case and in others.

The longer the U.S. allows its power and global standing to be undermined by this conflict, the more cost the United States will bear in reputation, taxpayer dollars, and possibly servicemember and citizens' lives. In your final months in office, we urge you to do everything in your power to end U.S. military aid to Israel to stop Israel's assaults on civilians and maintain regional stability.
